

# Society Records \$22 Million

**Dollars in Annuity Deposits  
Life Insurance Sales Total  
\$4.8 Million in New Issues**

Croatian Fraternal Union of America concluded the year 2025 on a high note issuing Annuity Contracts worth \$22 Million Dollars through December 31, 2025. The society has long subscribed to the practice of direct contact with members and potential members through organic means. Namely, through our *Zajedničar* that carries news of our favorable rate of return offered on the CHOICE TWO Annuity and IRA program. Additionally, we rely upon our faithful Lodge officers and membership for their "word of mouth" advertising of the various benefits, financial and social, of membership in the Croatian Fraternal Union of America.

The sales model employed by our society is unique in today's day and age where insurance companies and the vast majority of fraternal benefit societies utilize the services of professional sales agents to attract Annuity deposits and Life Insurance premium sales. While this method is perfectly fine for all others, our society has been able to thrive to a large degree through our "member get a member" philosophy. This has permitted CFU to afford a broad and varied cultural/sports program while at the same time continue increasing surplus and net wealth of our esteemed and longstanding financial organization.

To say that the financial markets have been turbulent over the past six years is an understatement of great proportions. Historically low interest rates greeted the COVID-19 virus in late 2019 and for the greater part of the next two years. The COVID-19 pandemic triggered the second-largest global recession, causing massive financial disruption through business closures, service sector slumps, surging unemployment, and trillions in lost GDP, particularly impacting service industries, with significant, varied impacts across nations and demographics, leading to widespread government fiscal responses and increased personal debt worries.

Croatian Fraternal Union of America weathered this stressful period all the while continuing to provide valuable financial benefits without failure. Our members enjoyed the benefit of our prudent and well-balanced portfolio of assets which protected their financial interests and safeguarded their future retirement savings. These turbulent times continued the abnormally low interest rates which had been prevalent for nearly twenty years previous-

ly. This was then followed by a period of time where the Federal Reserve caused Interest Rates to rise rapidly to stave off the resulting rampant inflation caused by both Fiscal and Monetary policy of the United States.

At the present time, we find ourselves in an easing cycle that now has the 10-year Treasury Bond in the mid-four-percent range. Our society's experience has been favorable in that our assets have been largely preserved over a timeframe in which many financial institutions have experienced a reduction in Assets under Management due to outflows of policyholder assets. In reviewing the results for year-end 2025, we find that CFU members have deposited \$22,145,000 into their Annuity and IRA accounts with the society which is an increase of seventy percent (70%) in comparison to the previous year's total of \$13,023,000.

Members have, in the vast majority, taken advantage of our Choice Two Annuity Contract offering 4.5% for a period of twenty-four months in order to ensure a favorable rate of return on their retirement dollars. We sincerely appreciate the faith and trust that our members have displayed in the Croatian Fraternal Union and its management through the placement of their hard-earned savings into our Annuity and IRA



# MINUTES

## EXECUTIVE BOARD MEETING MONDAY, DECEMBER 15, 2025

National President Pazo called the Meeting of the Executive Board to order at 10:15 a.m. with customary Fraternal Greetings.

In attendance were National President Edward W. Pazo, Executive Vice President Franjo Bertović (via Internet) and National Secretary/Treasurer Bernadette M. Luketich-Sikaras. Minutes of the Wednesday, November 12, 2025 meeting of the Executive Board were read and officially approved.

President Pazo opened the meeting with a review of the Home Office holiday work schedule for Christmas and New Year's. The annual Employee Holiday Luncheon will take place on Wednesday, December 23rd, with the Home Office closed for Christmas Eve and Christmas Day. The Members discussed the return to work on Friday, December 26th, which is normally a 4-hour workday and unanimously decided to not return to work until Monday, December 28th. The office will be closed on Thursday, January 1st.

President Pazo then presented several requests for merger from several Lodges that have been unable to fill critical officer positions because of decreasing membership and/or lack of interest in leadership positions among its members. After reviewing the requests, the Members unanimously voted to facilitate the following merger requests effective January 1, 2026:

1. "Liberty" ESL, Lodge 234 and Nest 652 Pittsburgh, PA to "Guardian Angel" Lodge 4 and Nest 21, Etna PA;
2. "Sveti Rok" Lodge 201 and Nest 131, Dunfermline, IL to "Sa-cred Heart" Lodge 367 and Nest 41, Canton, IL;
3. "Kardinal A. Stepinac" Lodge 500 and Nest 400, Cambridge, Ontario, Canada to "Hrvatska Sloga" Lodge 954 and Nest 603, Hamilton, Ontario, Canada.

President Pazo reviewed issues with the security and fire alarm system at the Home Office that are not being addressed by the current vendor company. A new company has been brought in to review the status of the system and to solicit a proposal for correcting and upgrading the system and the quality of our service.

President Pazo announced that Croatian Day with the Pittsburgh Pirates will be on May 30, 2026 when they play the Minnesota Twins. The game is scheduled for 4:05 pm, with discount tickets available through CFU. The Pirates are again preparing a Croatian-themed giveaway for all who purchase their tickets through CFU. 



# Prodaja anuiteta za 2025. godinu zabilježena je u iznosu od \$22.145.000 Ukupna prodaja životnog osiguranja iznosi \$4,8 milijuna

PITTSBURGH, PA - Hrvatska bratska zajednica Amerike završila je 2025. godinu u visokom tonu izdavanjem ugovora o anuitetima u vrijednosti od 22 milijuna dolara do 31. prosinca 2025. godine. Zajednica se dugo držala prakse izravnog kontakta s članovima i potencijalnim članovima putem organskih metoda. Naime, putem našeg Zajedničara koji donosi vijesti o povoljnoj stopi povratka ponuđenoj u programu "CHOICE TWO" Annuity i IRA. Osim toga, oslanjamo se na naše odane voditelje odsjeka i članstvo za njihovo „usmeno“ oglašavanje različitih pogodnosti, financijskih i društvenih, članstva u Hrvatskoj bratskoj zajednici.

Prodajni model koji koristi naša HBZ jedinstven je u današnje vrijeme, kada osiguravajuće tvrtke i velika većina bratskih dobrovornih društava koriste usluge profesionalnih prodajnih agenata kako bi privukli uplate anuiteta i premije za životno osiguranje. Iako je ova metoda sasvim prihvatljiva za sve druge, naša Zajednica je uspjela u velikoj mjeri napredovati kroz našu filozofiju „član dovede člana“. To je omogućilo HBZ-u da si priušti širok i raznolik kulturno-sportski program, a istovremeno nastavlja povećavati višak i neto bogatstvo naše cijenjene i dugovječne financijske organizacije.

Reći da su financijska tržišta bila turbulentna tijekom proteklih šest godina je velika podcjenja. Povjesno niske kamatne stope dočekale su virus COVID-19 krajem 2019. godine i većinu sljedeće dvije godine. Pandemija COVID-19 pokrenula je drugu najveću svjetsku recesiju, uzrokujući ogromne financijske poremećaje kroz zatvaranja poduzeća, padove sektora usluga, nagli rast nezaposlenosti i trilijune izgubljenog BDP-a, posebno pogodajući industrije usluga, s značajnim i raznolikim učincima po zemljama i demografskim skupinama, što je dovelo do široko rasprostranjenih fiskalnih mjera vlada i povećanih zabrinutosti zbog osobnog duga.

Hrvatska bratska zajednica izdržala je ovo stresno razdoblje, a istovremeno nastavljala pružati vrijedne financijske pogodnosti bez ikakvog prekida. Naši članovi uživali su u prednostima našeg razboritog i dobro uravnoteženog portfelja imovine koji je štitio njihove financijske interese i čuvali njihovu buduću štednju za mirovinu. Ova turbulentna vre-

mena nastavila su praksu nenormalno niskih kamata koje su bile prisutne gotovo dvadeset godina ranije. To je potom bilo praćeno razdobljem u kojem je Federalne rezerve dovele do brzog porasta kamatnih stopa kako bi sprječile rezultat splašnjene inflacije uzrokovane kako fiskalnom, tako i monetarnom politikom Sjedinjenih Američkih Država.

Trenutno se nalazimo u ciklusu popuštanja koji sada stavlja 10-godišnje državne obveznice u raspon sredine od četiri posto. Iskustvo naše HBZ bilo je povoljno u tom smislu što su naša sredstva uglavnom sačuvana u vremenskom razdoblju u kojem su mnoga financijska poduzeća doživjela smanjenje imovine pod upravljanjem zbog odliva sredstava osiguranika. Pregledom rezultata za kraj 2024. godine, utvrdili smo da su članovi HBZ-a položili 22.145.000 USD na svoje račune anuiteta i IRA kod naše Zajednice, što predstavlja povećanje od sedamdeset posto (70%) u usporedbi s ukupnim iznosom od 13.023.000 USD prethodne godine.

Članovi su u velikoj većini iskoristili naš Ugovor o anuitetu "Choice Two", koji nudi 4,5% za razdoblje od dvadeset četiri mjeseca, kako bi osigurali povoljan prinos na svoje mirovinske uplate. Iskreno cijenimo vjeru i povjerenje koje naši članovi pokazuju Hrvatskoj bratskoj zajednici i njezinom vodstvu kroz ulaganje svojih teško zarađenih uštedevina u naše ponude anuiteta i IRA računa. Članovi mogu biti sigurni da će HBZ uvijek nastojati osigurati pošten i promišljen prinos za naše članstvo dok štitimo imovinu naših članova u našem investicijskom portfelju.

## Nikola Tesla statue may leave Zagreb centre after 20 years

Zagreb – The future of Nikola Tesla's statue in central Zagreb has once again become the subject of public debate, following renewed discussion about returning the monument to the Ruder Bošković Institute (IRB), where it was originally intended to stand.

The bronze statue of Nikola Tesla, created by renowned Croatian sculptor Ivan Meštrović, has stood at the intersection of Teslina and Masarykova streets in downtown Zagreb for nearly two decades.

Its possible relocation back to the IRB campus, near Mirogoj Cemetery, has raised concerns about whether one of the world's most famous scientists would lose a prominent presence in the city centre.

The discussion resurfaced last week during commemorations marking the 83rd anniversary of Tesla's death. At the ceremony, wreaths were laid at the statue, and Karolj Skala, representing the management of the Ruder Bošković Institute, stated that an agreement had been reached with the City of Zagreb to return the statue to the Institute, possibly within the year.

However, the Institute later clarified that this statement was premature. While IRB has formally submitted a request to the City Office for Construction, Spatial Planning and Reconstruction, no final decision has yet been made.

### A monument with a deeper concept

The Tesla statue is part of a broader artistic and symbolic vision by Ivan Meštrović. Before creating the Tesla monument, Meštrović designed a statue of the physicist and philosopher Ruđer Bošković, which was placed within the grounds of the then Institute of Nuclear Physics, today's Ruđer Bošković Institute.

In 1956, Meštrović proposed creating a companion statue of Nikola Tesla to form a unique monument pair linking natural and technical sciences through two towering figures of Croatian intellectual history.

According to IRB, this pairing was conceived as a gift to the Institute and intended to function as a unified sculptural whole.

That concept remained intact until 2006, when, to mark the 150th anniversary of Tesla's birth, the City of Zagreb decided to move the statue into the city centre, to the street bearing Tesla's name.

The move was controversial from the outset. Heritage experts warned that the statue's dimensions were unsuitable for the narrow urban setting and that relocating it disrupted Meštrović's carefully designed conceptual pair.

The potential return of the statue to IRB has reopened

a key question: would Tesla effectively disappear from everyday public life in Zagreb? The Institute is located in a quieter area with far fewer passers-by than the bustling Lower Town, where the statue currently attracts both residents and tourists.</





## All CFU Members Must Be Made Aware of Privacy Act

The Gramm-Leach-Bliley Act, also known as the Privacy Act, was enacted by Congress on Nov. 13, 2000, with all states required to be in full compliance by July 1, 2001. State insurance regulatory authorities have been assigned responsibility for administration of the Act as it applies to insurance financial institutions, including the Croatian Fraternal Union of America. A significant feature of the Act is the inclusion of rules and requirements to protect an individual's non-public personal financial and medical information from distribution without the individual's consent.

Each financial institution must provide a privacy notice to all existing insureds. In compliance with this requirement, the CFU is sending this issue of the Zajedničar to all members which includes the following Privacy Act:

### PRIVACY - PERSONAL FINANCIAL AND MEDICAL INFORMATION

Protecting the privacy of your personal financial and medical information has always been and will continue to be a matter of top priority for us. When used in this notice, the following terms have the meaning shown.

\* **Public Information** means information that is lawfully available to the general public from: Federal, State or local government records; widely distributed media; or, disclosures to the general public that are required to be made by Federal, State or local law.

\* **Non-Public Information** means personally identifiable financial and medical information. It also means any list, description or other grouping of individuals, and publicly available information pertaining to them, that is derived from any personally identifiable information that is not publicly available.

\* **Consumer Reporting Agency** means an entity which regularly provides reports (Consumer Reports) including information regarding an individual's: general reputation, character, personal characteristics or mode of living and financial status. The information may be obtained through interviews with the individual or third parties such as the individual's: business associates, family members, friends, neighbors, acquaintances or financial sources.

We obtain information about you from the following sources:

\* information that we may receive from a Consumer Reporting Agency.

We do not disclose any personal, Non-Public, Information about you to anyone, except as permitted or required by law. We will not disclose personal medical information about you, except as permitted by law or as you may authorize.

We restrict access to your personal, insurance and medical information to those of our employees who need to know that information in order to provide insurance or service to you. We are, and will continue to be, vigilant in the safeguarding of your personal financial and medical information. We maintain physical, electronic and procedural safeguards to comply with Federal and State regulations regarding the safeguarding of Non-Public Information.

It is our sincere desire to maintain complete, accurate and up-to-date records. You may contact us at the address or telephone number shown above, to access, as provided by law, information included in your file. We will promptly correct any error in our information. To protect your privacy, you will need to identify yourself by providing us with your name, date of birth and social security number.





## Dr. Joseph Cindrich



**MENLO PARK, CA** - Dr. Joseph Cindrich, 90, of Menlo Park, died peacefully at the Veterans Administration Hospital in Palo Alto on October 24, 2025.

Joe, a proud Croatian American, co-founded the National Federation of Croatian Americans (NFCA) and served as its President for one term. Joe also spent over 25 years on the Executive Board of the Croatian Scholarship Fund (CSF), helping more than 500 Croatian students earn university degrees. In 1996, President Bill Clinton and Vice President Al Gore honored Joe at the White House where he was recognized for his work both at the NFCACF and with the Croatian Scholarship Fund. In 2018, Joe received a Lifetime Achievement Award in New York City for his support of Croatia by the then President, Kolinda Grabar-Kitarovic and also, he received the NFCACF's first Legacy Award in 2023 for his long-time Croatian activism.

Joe was born in Republic, PA on September 11, 1935. His parents were both immigrants from Croatia and his father Anthony was a coal miner. Joe briefly worked in the mines. However, his passion for football and desire to further his education served to propel him to accomplish many great things during his career. Joe was an outstanding high school football player at Redstone High School and was recognized for his play with many honors, including All-Conference and All-State. After receiving multiple college scholarship offers to play football, Joe attended the University of Pittsburgh and later transferred to the University of Tennessee.

Following the death of his father, Joe joined the United States Marines in 1955 to help support his family and serve his country. Joe played football for the Marines until a knee injury sidelined him. He then served as a football coach and supply officer for the Marines on the islands of Japan and Okinawa. Following his military service, Joe completed his B.S. and M.S. degrees at Indiana University. Joe started his professional career as a faculty member at Western Illinois University, where he met his wife, Karen. He earned a doctorate in Public Health from the University of Maryland in 1975 before serving in several roles within the federal government in Washington, D.C.

Joe served nine years as Health and Safety Manager at the U.S. Department of Agriculture, where he improved safety standards for the meat, poultry, and grain industries. In 1987, he moved to the San Francisco Bay Area to become Regional Administrator at the National Highway Traffic Safety Administration, leading efforts to enact seatbelt, DUI, and motorcycle helmet laws. He retired in 1998 after 21 years of service in Federal government.

Joe chaired the Palo Alto Elks Lodge Board of Trustees for five years and was integral in developing a strategic plan to build a new facility. A celebration of life service will be held in Joe's honor at the Palo Alto Elks Lodge on Saturday, February 28th.

Joe was predeceased by his wife Karen (2015), his father and mother, Anthony (1954) and Agnes (1958); sisters Katherine Kasmarcak (2011), Anne Chromey (2000), and Mary Alice Lapsevich (2018); and brothers Mike Cindrich (2011), George Cindrich (2018), and Paul Cindrich (2022).

Joe and Karen were married for forty-four years until her death in 2015. Joe had a daughter from a previous marriage, Tanja Marie Hayes, who died in 2016 in Bloomington, Indiana. He is survived by two grandchildren, Santana Hayes and Jance Hunt, as well as numerous nieces and nephews.

I am also proud to share that Dr. Joseph Cindrich was a longtime friend of my dad, Joseph Rukavina, and they first met in the 1950s at a University of Minnesota and Indiana Hoosiers football game. Joe's love for Croatia and his unwavering commitment to the NFCACF and the CSF will remain his enduring legacy to our community, as will his soon to be announced, CFU Scholarship Fund in his name. May Joe rest in eternal peace.

## Mate Meštrović has passed away



**ZAGREB** - He is also known to the general public as the son of Ivan Meštrović. From 1980 to 1982, he was the Head of Foreign Affairs, and from 1982 to 1991, he was the President of the Executive Committee of the Croatian National Council.

At the age of 96, after a short illness, the well-known diplomat, historian and journalist, also widely known as the son of Ivan Meštrović, Mate Meštrović, passed away.

Prime Minister Andrej Plenković sent following condolences:

"I received with sadness the news of the death of Mate Meštrović, a prominent journalist, historian, and politician, the son of the great Croatian sculptor Ivan Meštrović, who dedicated a significant part of his professional and personal life to presenting Croatian history, political aspirations, and identity to the international public."

As a journalist and public intellectual, he wrote for American and British publications as well as the Croatian émigré press, appeared in international media, and gave numerous interviews to foreign audiences, especially during periods when the Croatian voice was difficult to hear.

He deepened his contribution through scientific and journalistic work, as the author of books and numerous articles and as the editor of the English edition of Dr. Franjo Tuđman's book, **The National Question in Contemporary Europe**, contributing to a better understanding of Croatian historical and political realities in an international context. As a historian and professor of contemporary European history at an American university, he conveyed knowledge to students and, through participation in seminars and public lectures, contributed to the understanding of European and Yugoslav processes from a perspective important for Croatia. After the establishment of the independent Croatian state, he returned to his homeland and, as a representative in the County Chamber of the Croatian Parliament and as the ambassador of the Republic of Croatia to Bulgaria, he put his experience at the service of Croatian institutions and foreign policy.

Mate Meštrović will be remembered as one of those who kept Croatian political thought alive and recognizable in exile, making an exceptional contribution to the activities of the Croatian political emigration and later putting that experience at the service of the independent Croatian state. On behalf of the Government of the Republic of Croatia and personally, I extend my sincere condolences and deepest respects to the family, friends, and colleagues of Mr. Mate Meštrović."

Meštrović was born in Zagreb in 1930. He completed elementary school in Zagreb and continued his education abroad. From 1942, they first lived in Rome, then in Switzerland, and finally in the USA from 1947. In 1951, he graduated, and in 1952 he earned his master's degree at Syracuse University in the USA.

During the Korean War, he served in the American army as a lieutenant. After returning from the war and leaving the military, he earned his doctorate in 1957 at Columbia University in New York. After that, he worked as a journalist for ten years, and from 1967 to 1991, he taught modern European history at Fairleigh Dickinson University in New Jersey.

Among other works, he published following: In the Struggle for Croatia: Collected Articles (1980-1986) (1986), In the Whirlwind of Croatian Politics: A Narrative to Peri Zlatar (2003), and others.

From 1980 to 1982, he was Head of Foreign Affairs, and from 1982 to 1991, he served as President of the Executive Committee of the Croatian National Council (HNV), the umbrella political organization of the Croatian political diaspora. At the beginning of 1990, he returned to his homeland, and in 1993, he was elected as a representative in the County Chamber of the Croatian Parliament. After his term as a representative ended, he was appointed Ambassador of the Republic of Croatia to Bulgaria, a position he held from 1997 to 2000.

He is survived by his wife Rumi Meštrović and son Simon Meštrović. Burial was private.

# Cooking Corner

## Lasagna Rolls

### Cheese Filling:

1 lb. ricotta cheese  
1 cup mozzarella cheese, shredded  
1/4 cup Parmesan or Romano cheese  
2 tsp. chopped parsley  
salt and pepper to taste  
2 eggs

Mix all of the ingredients except for the eggs. Add one egg and mix well. Mixture should be firm. If cheese seems too dry, add part of the other egg or entire egg. Mixture should not be loose. Cover and refrigerate.

HINT: Cheese filling can be made a day ahead of assembly.

### Meat Filling:

1 lb. Italian sausage, remove casings  
1/2 lb. ground chuck  
1 small onion, finely chopped  
2 large cloves garlic, chopped  
Sprinkles of basil  
Salt and pepper to taste  
2 Tbsp. olive oil  
Tomato pasta sauce

Sauté onions and garlic in oil for 2 minutes. Add meat and brown until meat shows no pink areas. Break up meat while sizzling. Remove excess grease from pan. Add enough pasta sauce to meat mixture until well coated, but not saturated, (about 3/4 cup sauce). Blend well. Let cool a few minutes before assembling.

Boil the noodles according to box directions less one minute. Add 1 tsp. oil to salted water. Drain and rinse with cold water. Place a towel on counter and lay noodles on towel to cool. Cover with saran to keep from drying out.

HINT: cook the noodles while preparing the sausage filling.

### To Assemble:

On each noodle, spoon 3 Tbsp. of meat and 2 Tbsp. of cheese. Start and end with the meat. Dot each meat mound with 1 tsp. sauce. Pour a little sauce on bottom of baking dish. Gently roll each noodle and place on top of the sauce seam side down. Be sure there is a little space between each roll for easy removal. Pour enough sauce over each roll to coat evenly.

Place dish on baking sheet and bake uncovered at 350 degree for 35 minutes. Add shredded mozzarella and parmesan cheese over rolls and bake an additional 10 minutes. Amount of cheese used depends on your taste. If cheese starts to brown, cover lightly with foil.

Bake at 350 degrees for 40 to 45 minutes. Cover and let rest in dish a few minutes before serving.

### Make Ahead Directions:

Prepare as directed above. Cover with saran and refrigerate for up to 24 hours.

Remove from refrigerator and bake covered in 375 degree oven for 40 minutes. Uncover and bake 15 minutes more. Add the cheese topping and bake another 5 minutes or so until cheese melts. Adjust the baking time as you see fit. Cover and let rest a few minutes before serving.

## Dubrovnik Minestrone (Dubrovacka minestra)

The Croatian minestrone soups have obvious Italian influences. This isn't surprising since Dubrovnik and other Croatian cities sometimes fell under Italian rule throughout their long histories. Serves 6.

1/4 lb. dried mutton  
1/2 lb. smoked pork  
3 medium potatoes, peeled and diced  
1/4 lb. brussel sprouts  
2 small zucchini, diced  
1 c. French green beans, trimmed  
1 to 2 links smoked and dried pork sausage, sliced  
2 Tbsp. olive oil

1/4 c. finely diced, smoked bacon  
3 Tbsp. chopped parsley

2 to 3 cloves garlic, minced

In a large stock pot, cover the mutton and smoked pork with water. Bring to a boil over medium heat and then remove the meat and set aside. Discard the water. Add fresh cold water (this step takes excess saltiness or smokiness out of the soup), and the potatoes, brussel sprouts, zucchini and beans. When the vegetables are about half done, add the sausage.

In a small bowl mix together the olive oil, bacon, parsley and garlic. Add to the soup stirring thoroughly. Next, cut the meat into small pieces and return to the soup. Simmer until all ingredients are tender and done.

\*Time-saver: Use canned or frozen French green beans in order to avoid having to clean and trim them.

\*Heart-healthy: Use lean cuts of meat and lean sausages. Use only one sausage and reduce the meat by half.

of a lesser-known statue of Tesla by sculptor Velibor Mačukatin, created in 1954, which once stood at the Radio Industry Zagreb factory. Its current whereabouts are unclear, but it could represent a more proportionate option for the site.

The Lower Town District Council has expressed openness to such an approach. Its president, Marija Krnić, emphasised the need for public consultation and professional input, rather than ad hoc decisions.

She described the original placement of the Meštrović statue in Teslina Street as an example of poor public space management.

Both IRB and the Museums of Ivan Meštrović argue that returning the statue would not remove it from public life, but

rather restore it to its original conceptual and architectural context.

They maintain that the current location fails to meet the sculpture's spatial and artistic requirements and undermines its intended relationship with the Bošković monument.

For Mihajlović, the key issue remains public interest. She argues that citizens have the right to accessible cultural heritage and public spaces that reflect shared values such as knowledge, creativity, humanism and peace.

As Zagreb awaits a final decision, the debate highlights a broader challenge: how to balance artistic integrity, historical context and public visibility when managing cultural heritage in a modern European capital.

## Croatia PM Responds to Trump's "Board of Peace" Invitation

Croatian Prime Minister Andrej Plenković has responded to an invitation from United States President Donald Trump for Croatia to join a newly announced international initiative known as the "Board of Peace", stressing that the government values the proposal but is currently reviewing its legal and political implications.

President Trump unveiled the initiative today during the World Economic Forum in Davos, Switzerland, describing it as a body aimed at rebuilding Gaza and addressing major global conflicts.

Trump stated that the board should work alongside the United Nations, despite reiterating his criticism of the organisation.

In a statement published on social media platform X, Prime Minister Plenković said Croatia highly appreciates the invitation, but underlined that a thorough assessment is underway.

"I highly appreciate the invitation extended by @POTUS to join the Board of Peace. Supporting and advancing the historic peace process in the Middle East remains one of the most important and noble objectives we share with the United States and the broader international community."

In this spirit, the Croatian Government is currently assessing the legal and other aspects of the proposal and will constructively engage with our U.S. and European partners going forward.

"We will continue to strongly advocate for preserving and strengthening the transatlantic relationship and for advancing the cause of peace in the Middle East and beyond," Plenković said.

Plenković's response drew praise from US Ambassador to Croatia Nicole McGraw, who publicly thanked the Prime Minister for Croatia's support for peace and its role as a dependable American ally.

"Thank you, Prime Minister @AndrejPlenkovic, for supporting peace, for standing as a steadfast ally, and for your continued leadership in strengthening the partnership between the United States and Croatia," McGraw stated on X.
